Appropriate accommodations for children with disabilities with respect to health and safety policies	Y	All students may wear masks and socially distant inside the classrooms as well as outside.
Coordination with State and local health officials	Y	Exposure guidelines from Yavapai County and the CDC are monitored weekly and changes to the school plan made accordingly. Links to these guidelines are on our school website.
